About the scheme

The Queensland Sheep and Goat Electronic Identification Rebate Scheme is being introduced to strengthen livestock traceability. Sheep and goat mandatory individual electronic identification (eID) improves biosecurity and traceability, including accurate and timely tracing to help reduce the duration and industry impact of an emergency animal disease outbreak or residue incident.

The purpose of the Queensland Sheep and Goat Electronic Identification Rebate Scheme (the Scheme) is to encourage uptake and compliance with the introduction of mandatory eID of sheep and goats in Queensland by giving primary producers and livestock agents a rebate to offset up to half the cost of purchasing eligible hardware.

Please note, program funding is limited. Completed applications will be assessed in order of submission (i.e. first-in, first-served). **Rebates will be available until the Scheme's closing day on 30 June 2025, unless Scheme funding is exhausted prior.**

Available funding

The amount of assistance available under the Scheme is up to half of the cost of eligible hardware. Maximum assistance available for the following entities is outlined below:

Primary producers	\$1,600 for each property identification code (PIC) allocated to the primary producer
Livestock agents	\$1,600 one application per business address in Queensland

To be eligible for assistance, an applicant must:

- be a primary producer or a livestock agent; and
- have purchased eligible hardware on or after 1 January 2023.

For the purpose of this Scheme, a **Livestock Agent** is:

- an entity who holds:
 - an Australian Business Number (ABN) and;
 - an NLIS account as an agent that, within the 12 months immediately before making an application under the Scheme, recorded the movement of sheep or goats off a designated place for which a PIC has been allocated.
- who carries on a business as a livestock agent in Queensland; and
- whose principal place of business is located in Queensland.
